Supporting a Sustainable Future was developed following a robust methodology led by our sustainability advisors, <u>JustOne</u>. This process involved detailed research, industry analysis, stakeholder engagement and workshops to define the sustainability issues most material to our stakeholders and business. In line with best practice, we developed a double materiality matrix assessment. The result is presented in this report and has informed the creation of the strategy framework and long-term goals for each sustainability issue we are addressing.

Our vision for 2027 is to support the transformation of our sector to a sustainable future, through our expertise and exceptional people. Our sustainability strategy is formed of three focus areas, addressing ten sustainability issues across social, environmental and governance topics, with 16 long-term goals to be achieved by the end of 2027.

We work hard to ensure our team feel continually fulfilled at work. Helping East Street Arts Achieve Their Mission

Our business is part of the growing, vibrant and increasingly diverse City of Leeds, and we are proud to have our HQ located right by the River Aire.
